THEY ACCOMPLISH THIS MISSION THROUGH PARTNERSHIP WITH INDIGENOUS CHURCHES AND LEADERSHIP TRAINING TO DISCIPLE AND RESTORE THE LIVES OF ORPHANS AND WIDOWS. DEDICATED ORPHAN RESCUE TEAMS VENTURE BOLDLY INTO WAR ZONES, JUNGLES, SLUMS AND REFUGEE CAMPS TO RESCUE ORPHANS. THEY GIVE HOPE TO DESPERATE WIDOWS WHO HAVE BEEN ABANDONED BY THEIR FAMILY AND COMMUNITY, PROVIDING THEM A SENSE OF PURPOSE IN THE LOVING ATMOSPHERE OF A CHURCH ORPHAN HOME. TO DATE, WARM BLANKETS ORPHAN CARE HAS RESCUED THOUSANDS OF ORPHANS FROM THEIR DIRE CIRCUMSTANCES AND PLACED THEM IN OVER 200 SAFE AND SECURE CHURCH ORPHAN HOMES WHERE THEY ARE RAISED AND LOVED BY THE LOCAL PASTOR, HIS WIFE AND WIDOWS FROM THE COMMUNITY.
